## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Elderly Program Title VI Budget)

WHEREAS, the Tohono O'odham Nation has successfully operated a
program for the elderly members of the Nation; and
WHEREAS, funding for the operation of the Elderly Program has been
possible in part by Article VI of the Older American's Act
of 1965 as amended; and
WHEREAS, the Elderly Program desires to seek continued funding by
submitting a proposal to the Office of Human Development
Services, Administration on Aging; and
WHEREAS, the Elderly proposal will benefit elder members of the
Tohono O'odham Nation by providing for their nutritional
and social support services.
NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
Council that it hereby approves the proposal for continued
funding of the Elderly Program to provide services to
eligible members of the Tohono O'odham Nation.
BE IT FURTHER RESOLVED that the term of this grant shall commence
on April 01, 1990 and end on March 31, 1992.
BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
that the Tohono O'odham Nation will not fund or operate
the program in the interim while negotiations are still
being conducted and no executed grant has been awarded by
the Office of Human Development Services, Administration
on Aging.
BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
that the Tohono O'odham Nation's Officials, to wit: The
Chairman, Vice Chairman and any designated official are
hereby authorized to negotiate and execute the grant,
provided, however, that any amendments affecting the
funding or funding levels of this grant shall be submitted
for further prior approval by this Council.
The foregoing Resolution was passed by the Tohono O'odham Council on the 2nd day of April, 1990 at a meeting at which a quorum was present with a vote of 1,431.0 for; -0- against; 293.0 not voting; 03 absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham
