

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Skill Center Contract No. CTH50007090
Budget Modification #1)

RES. NO. 99-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the Skill
2 Center Program under FY'90 P. L. 93-638 contract with the
3 Bureau of Indian Affairs; and

4 WHEREAS, any amendments affecting the funding or funding levels of
5 the contract shall be submitted for review and approval
6 by the Tohono O'odham Legislative Council; and

7 WHEREAS, the Department of Interior has received in accordance with
8 the Appropriation Act of 1990, a reduction of 5.3%; and

9 WHEREAS, the Bureau of Indian Affairs has requested the Nation to
10 submit revised budget modifications to reflect Gramm-
11 Rudman-Hollings reductions reflected in the Appropriation
12 Act of 1990; and

13 WHEREAS, an amendment has been submitted for review and approval.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
15 Council does hereby approve this amendment and authorizes
16 expenditures in accordance with the attached budget.

17 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
18 that the Tohono O'odham Nation's Officials, to wit: the
19 Chairman, Vice-Chairman and any designated official are
20 hereby authorized to negotiate and execute the contract,
21 provided however, that any amendments affecting the
22 funding or funding levels of the contract shall be
23 submitted for further prior approval by this Council.

24 The foregoing Resolution was passed by the Tohono O'odham Council
25 on the 3rd. day of April, 1990 at a meeting at which a quorum was
26 present with a vote of 1,618.0 for; 106.0 against; -0- not
27 voting; 03 absent, pursuant to the powers vested in the Council
28 by Section 1 (f) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
