WHEREAS, two members of the Water Resources Committee of the Legislative Council and other representatives of the Tohono O'Odham Nation met with federal officials in Washington, D.C. on December 13 and 14, 1990 to discuss the Nation's water rights in the Chuichu area and under the Southern Arizona Water Rights Settlement Act (SAWRSA); and

WHEREAS, one of the topics of discussion was the creation of federal negotiating teams to meet with the Nation's officials regarding the Chuichu water claim and problems which have arisen under SAWRSA; and

WHEREAS, the Water Resources Committee recommends that the Legislative Council request establishment of separate federal negotiating teams with the authority to immediately commence discussions with the Nation's duly authorized officials in an effort to reach fair and final resolutions of these claims.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Water Resources Committee and the Attorney General are authorized and directed to transmit a letter to the Secretary of Interior requesting the establishment of separate federal negotiating teams for the Chuichu water claim and issues which have arisen under SAWRSA affecting the Nation's rights under that Act.
- 2. Following consultation with the Chairman of the Tohono O'Odham Nation, the Sif Oidak District Council, San Xavier District Council, and the Schuk Toak District Council, the Water Resources Committee and the Attorney General are further authorized to recommend to the Secretary of Interior the names of persons whom the Tohono O'Odham Nation requests be assigned to each Federal Negotiating Team.
