

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Extension of the Water Distribution Study -
Contract No. 7-CS-30-5900)

2 WHEREAS, the Tohono O'Odham Nation has been under contract to
3 provide planning and administrative services under a P.L.
4 93-638 contract with the Bureau of Reclamation; and

5 WHEREAS, the three year P.L. 93-638 contract expired on 27 August
6 1990; and

7 WHEREAS, additional time is required to complete tasks which are
8 associated with the contract.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
10 Council that it does authorize and request the Bureau of
11 Reclamation to extend Contract No. 7-CS-30-5900 (Studies
12 and Planning Activities necessary for the Design and
13 Construction of Facilities for the Delivery and
14 Distribution of Water to the San Xavier Reservation and
15 Schuk Toak District) with the Tohono O'Odham Nation under
16 the P.L. 93-638 Regulations.

17 BE IT FURTHER RESOLVED that the duration of this contract extension
18 will commence on August 28, 1990 through August 28, 1991.


19 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
20 that the Tohono O'Odham Nation's Officials, to wit: the
21 Chairman, Vice Chairman and designated official are hereby
22 authorized to execute the extension of the contract,
23 provided however that any amendments affecting the funding
24 or funding levels of the contract shall be submitted for
25 further prior approval by this Council.

26 The foregoing Resolution was passed by the Tohono O'odham Council
27 on the 10th, day of January, 1991 at a meeting at which a quorum
28 was present with a vote of 1,610.0 for; -0- against; 114.0 not




