WHEREAS, the Tohono O'Odham Nation has been under contract to provide planning and administrative services under a P.L. 93-638 contract with the Bureau of Reclamation; and

WHEREAS, the three year P.L. 93-638 contract expired on 27 August 1990; and

WHEREAS, additional time is required to complete tasks which are associated with the contract.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does authorize and request the Bureau of Reclamation to extend Contract No. 7-CS-30-5900 (Studies and Planning Activities necessary for the Design and Construction of Facilities for the Delivery and Distribution of Water to the San Xavier Reservation and Schuk Toak District) with the Tohono O'Odham Nation under the P.L. 93-638 Regulations.

BE IT FURTHER RESOLVED that the duration of this contract extension will commence on August 28, 1990 through August 28, 1991.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and designated official are hereby authorized to execute the extension of the contract, provided however that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.
