WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and

WHEREAS, the Tohono O'Odham Nation wishes to continue its efforts towards the design of the San Xavier Cooperative Farm and the implementation of SAWRSA; and

WHEREAS, reports, plans and other deliverables are necessary from contractors to the Tohono O'Odham Nation in order to continue these efforts; and

WHEREAS, additional funds are required in order to pay for outstanding invoices from contractors to the Tohono O'Odham Nation, and additional funds are required in order to pay for the completion of the design of the San Xavier Cooperative Farm; and

WHEREAS, this amendment has been submitted by the Tohono O'Odham Nation's Water Projects Office for consultant services for the Pre-design (Modification Nos. 15, 16 and 17) and Design (Modification Nos. 18 and 19) phases for review and approval.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does authorize and request the Bureau of Reclamation to modify Contract No. 8-CS-30-04830 consistent with Budget Modifications 15, 16, 17, 18 and 19 described above and attached hereto, with the Tohono
