NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that, subject to the approval of the Secretary of the Interior, the name of the following person be added to the official census rolls of the Sells, Gila Bend or San Xavier Reservation, to wit:

## 20-CK-90 ANTONE, MARY

BE IT FURTHER RESOLVED that the required approval be secured from the Secretary of the Interior before their name be formally added to such rolls.

The foregoing resolution was passed by the Tohono O'odham Council on the 4th day of February, 1991, at a meeting at which a quorum was present with a vote of 1,534.5 for; -0- against; 189.5 not voting; and 02 absent; pursuant to the powers vested in the Council by Section 1 (a) of Article II and Section 1 (h) of Article VI of
