NO. 91-042 1 WHEREAS, the Tohono O'odham Nation possesses cash and liquid assets 2 in excess of its daily cash requirements for operations; 3 and 4 WHEREAS, the Legislative Council of the Tohono O'odham Nation 5 wishes to delegate management of these resources on a day-6 to-day basis, subject to policies approved by the 7 Legislative Council; and 8 WHEREAS, the Budget and Finance Committee of the Legislative 9 Council of the Tohono O'odham Nation has considered 10 investment policies and procedures and it brings a policy 11 for consideration of the Legislative Council in the 12 attached memorandum titled, "FINANCIAL INVESTMENT POLICY 13 OF THE TOHONO O'ODHAM NATION;" and 14 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the 15 Tohono O'odham Nation adopts the Financial Investment 16 Policy. **17** BE IT FURTHER RESOLVED that the Investment Committee, established 18 according to that policy, shall issue a Request for 19 Proposals for selection of Investment Advisors prior to 20 March 1, 1991. 21 BE IT FURTHER RESOLVED that the Legislative Budget and Finance 22 Committee, during the March General Session, provide a **2**3 status report on the activities to implement this policy. 24 The foregoing Resolution was passed by the Tohono O'odham Council 25 on the 4th day of February, 1991 at a meeting at which a quorum was present with a vote of 1,494.0 for; -0- against; 230.0 not voting; 26 01 absent, pursuant to the powers vested in the Council by Section 1 (d) (2) of Article VI of the Constitution of the Tohono O'odham 27 Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian 28
