6 Nation, and that their applications are approved, as  
7 herein above indicated.

8 BE IT FURTHER RESOLVED that the Chairman and other appropriate  
9 officers of the Tohono O'Odham Nation reduce this final  
10 determination in writing regarding each of the foregoing  
11 applications for enrollment in accordance with Section 3  
12 (c) of Article III of the Enrollment Ordinance; give  
13 notice of this Council's determination in accordance with  
14 Section 4 of Article III of the Enrollment Ordinance; and  
15 place the names of each applicant upon the membership roll  
16 of the Tohono O'Odham Nation in accordance with Article  
17 V of the Enrollment Ordinance.

19 The foregoing Resolution was passed by the Tohono O'Odham Council  
20 on the 4th day of February, 1991 at a meeting at which a quorum  
21 was present with a vote of 1,291.0 for; -0- against; 433.0 not  
22 voting; and 03 absent, pursuant to the powers vested in the  
23 Council by Section 1 of Article II and of Section 1 (h) of Article  
24 VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
25 Tohono O'Odham Nation on January 18, 1986 and approved by the  
26 Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
27 March 6, 1986 pursuant to Section 16 of the Act of June 18, 1934  
28 (48 Stat. 984).
