

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL
(Proceed in Closed Session to Discuss Defeated Res. #91-049)

LEGISLATIVE ORDER NO. 91-051

2 WHEREAS, by Legislative Order No. 91-050, the Tohono O'odham
3 Legislative Council amended its agenda for February 6,
4 1991 to include an interview of Evelyn B. Juan for the
5 position of Judge for the Tohono O'odham Courts; and

6 WHEREAS, on February 5, 1991 the Tohono O'odham Legislative
7 Council, by Legislative Order 91-048 disapproved tabling
8 action on the resolution Appointing Evelyn B. Juan as a
9 judge of the Tohono O'odham Courts; and

10 WHEREAS, on February 5, 1991 the Tohono O'odham Legislative Council
11 voted on the Resolution to appoint Evelyn B. Juan as a
12 judge of the Tohono O'odham Courts, said resolution was
13 defeated; and

14 WHEREAS, a request was made to discuss defeated Resolution No. 91-
15 049 in closed session.

16 NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative
17 Council closes its discuss defeated Resolution No. 91-049,
18 "Appointing Evelyn B. Juan as Judge of Tohono O'odham
19 Courts."

20 The foregoing Order was passed by the Tohono O'odham Council on
21 the 6th day of February, 1991 at a meeting at which a quorum was
22 present with a vote of 1,474.5 for; -0- against; 249.5 not
23 voting; 02 absent, pursuant to the powers vested in the Council by
24 Section 1(a) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
