

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1992 Tuberculosis Control Program)

2 WHEREAS, the Tohono O'Odham Nation has operated a Tuberculosis
3 Control Program to help prevent the spread of the disease
4 through community education, prevention, early detection,
5 comprehensive regimens and careful follow up for
6 individuals; and

7 WHEREAS, funding for the operation of the Tohono O'Odham
8 Tuberculosis Control Program has been provided in part
9 through supplemental funding sources; and

10 WHEREAS, the Tohono O'Odham Tuberculosis Control Program desires
11 to continue the services it provides to TB susceptible
12 patients; and

13 WHEREAS, the Tohono O'Odham Tuberculosis Control Program has
14 received funding from the Department of Health Services,
15 State of Arizona for its program.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
17 Council that it hereby approves the proposal for funding
18 of the Tohono O'Odham Tuberculosis Control Program from
19 the Department of Health Services, State of Arizona and
20 that the duration of this contract will be from July 01,
21 1991 through June 30, 1992 unless extended by mutual
22 agreement of both contracting parties.

23 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
24 that the Tohono O'Odham Nation will not fund or operate
25 the program in the interim while negotiations are still
26 being conducted and no executed contract has been awarded
27 by the Department of Health Services, State of Arizona.

2 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
3 that the Tohono O'Odham Nation's Officials, to wit: the
4 Chairman, Vice Chairman and any designated official are
5 hereby authorized to negotiate and execute the contract,
6 provided however, that any amendments affecting the
7 funding levels of the contract shall be submitted for
8 further prior approval by this Council.

9 The foregoing Resolution was passed by the Tohono O'odham Council
10 on the 4th. day of March, 1991 at a meeting at which a quorum was
11 present with a vote of 1,543.5 for; -0- against; 180.5 not
12 voting; 03 absent, pursuant to the powers vested in the Council
13 by Section 1(f) of Article VI of the Constitution of the Tohono
14 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
15 1986, and approved by the Acting Deputy Assistant Secretary -
16 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
17 16 of the Act of June 18, 1934 (48 Stat. 984).






