## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (FY 1992 Tuberculosis Control Program)

RES. NO. 91-065 1 WHEREAS, the Tohono O'Odham Nation has operated a Tuberculosis 2 Control Program to help prevent the spread of the disease 3 through community education, prevention, early detection, 4 comprehensive regimens and careful follow for 5 individuals; and 6 Tohono O'Odham for the operation of the WHEREAS, funding 7 Tuberculosis Control Program has been provided in part 8 through supplemental funding sources; and 9 WHEREAS, the Tohono O'Odham Tuberculosis Control Program desires 10 to continue the services it provides to TB susceptible 11 patients; and 12 WHEREAS, the Tohono O'Odham Tuberculosis Control Program has 13 received funding from the Department of Health Services, 14 State of Arizona for its program. 15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative 16 Council that it hereby approves the proposal for funding 17 of the Tohono O'Odham Tuberculosis Control Program from 18 the Department of Health Services, State of Arizona and 19 that the duration of this contract will be from July 01, 20 1991 through June 30, 1992 unless extended by mutual 21 agreement of both contracting parties. 22 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council 23 that the Tohono O'Odham Nation will not fund or operate 24 the program in the interim while negotiations are still 25 being conducted and no executed contract has been awarded 26 by the Department of Health Services, State of Arizona.
