WHEREAS, the Tohono O'Odham Nation is presently operating the Community Health Services Program under FY 1991 P.L. 93-638 contract with the Public Health, Indian Health Services; and

WHEREAS, such tribal operation has been successful and beneficial to the Tohono O'Odham Nation and its people; and

whereas, the Tohono O'Odham Nation has been notified that funds are available for AIDS Prevention Services to assist health education and promotion; as well as disease prevention, management and treatment to individuals, families, groups and communities; and

whereas, in order to meet the needs of our O'Odham with AIDS education and prevention, the staff in the Health Department need to be trained in counseling with People With AIDS (PWA); and

WHEREAS, the Tohono O'Odham Nation has submitted a workplan and budget to assist in staff counseling training and to assist themselves in counseling with People With AIDS (PWA); and

WHEREAS, the Tohono O'Odham Legislative Council has reviewed and approved the workplan and budget for AIDS.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves and requests Indian Health Services to modify the Community Health Services Contract No. 249-88-0011 to incorporate the attached workplan and budget.
