L. 4 93-638 contract with the Public Health, Indian Health 5 Services; and 6 WHEREAS, such tribal operations have been successful and beneficial 7 to the Tohono O'odham Nation and its people; and 8 WHEREAS. the Tohono O'Odham Nation has been notified that funds are 9 available for Community Health Representative Specialty 10 Training to assist Community Health Representative 11 personnel in communicating, documenting and reporting 12 health service activities; and 13 WHEREAS, the Tohono O'Odham Legislative Council has reviewed and 14 approved the Community Health Representative Specialty 15 Training Plan and Budget. 16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative 17 Council that it hereby approves and requests Indian Health 18 Services to modify the Community Health Services Contract 19 No. 249-88-0011 to incorporate the attached Training Plan 20 and Budget. 21 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council 22 that the Tohono O'Odham Nation's Officials, to wit: 23 Chairman, Vice Chairman and any designated official are 24 hereby authorized to negotiate and execute the contract, 25 provided however, that any amendments affecting the 26 funding or funding levels of this contract shall be 27

submitted for further approval by this Council.
