WHEREAS, the Pisinemo District Council of the Pisinemo District did on February 23, 1991 by District Resolution 01-91, approve their six (6) month District Budget in the amount of Forty Nine Thousand Eight Hundred Thirty Nine Dollars and Sixty Cents (\$49,839.60); and

WHEREAS, the six (6) month budget and budget period would be from April 01, 1991 to September 30, 1991; and

WHEREAS, the Pisinemo District Council did review and discuss the needs of the people of Pisinemo District, the need to have a District Office with an operating budget, and District staff; and

WHEREAS, the Pisinemo District has sufficient funds in their account which is on deposit with the Tohono O'Odham Nation's Accounting Department to cover their proposed budget; and

WHEREAS, the Tohono O'odham Legislative Council has reviewed the Pisinemo District proposed budget and budget justification which is attached and finds it in order.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves the Pisinemo District FY 1991 Six (6) Month Budget request as presented in the amount of Forty Nine Thousand Eight Hundred Thirty Nine Dollars and Sixty Cents (\$49,839.60) and authorizes expenditures in accordance therewith.


BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves the request by the Pisinemo


District Council to modify said budget as needed or as necessary and to bring before the Legislative Council for approval any actions by the Pisinemo District Council to amend said budget.

The foregoing Resolution was passed by the Tohono O'odham Council on the 5th. day of March, 1991 at a meeting at which a quorum was present with a vote of 1,724.0 for; -0- against; -0- not voting; 01 absent, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






