NO. 91-075 2 WHEREAS, the Tohono O'Odham Nation (Nation) suffers from a number 3 of illness and diseases including, but not limited to 4 alcoholism, diabetes mellitus, tuberculosis and a lack of 5 emergency medical services and basic transportation; and 6 WHEREAS, the Nation, through its health and social services 7 departments offers programs concerned with the delivery 8 of services which addresses the illnesses and diseases 9 afflicting the Nation; and WHEREAS, present staffing and funding for delivery of such services 10 11 is inadequate to meet the high demand of patients and 12 clients suffering from these conditions and the continuing rise in the number of patients and clients needing 13 14 services; and 15 WHEREAS, the Indian Health Service's staffing and resources are also inadequate to fully meet the demand and rise in the 16 incidence of the Nation's illness and disease; and 17 WHEREAS, it is the desire of the Nation to address the many health 18 19 needs of its people. **2**0 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby urgently request that the 21 22 Congress appropriate \$2,817,069. in accordance with the 23 attached proposals, to assist the Nation in meeting the rise and demand for health services. 24 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council 25 26 that the appropriate officers of the Nation are hereby authorized and directed to bring this request to the 27 appropriate members and committees of Congress. 28
