

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(1992 Appropriations Request to Congress - Health)

2 WHEREAS, the Tohono O'Odham Nation (Nation) suffers from a number
3 of illness and diseases including, but not limited to
4 alcoholism, diabetes mellitus, tuberculosis and a lack of
5 emergency medical services and basic transportation; and

6 WHEREAS, the Nation, through its health and social services
7 departments offers programs concerned with the delivery
8 of services which addresses the illnesses and diseases
9 afflicting the Nation; and

10 WHEREAS, present staffing and funding for delivery of such services
11 is inadequate to meet the high demand of patients and
12 clients suffering from these conditions and the continuing
13 rise in the number of patients and clients needing
14 services; and

15 WHEREAS, the Indian Health Service's staffing and resources are
16 also inadequate to fully meet the demand and rise in the
17 incidence of the Nation's illness and disease; and

18 WHEREAS, it is the desire of the Nation to address the many health
19 needs of its people.

20 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
21 Council that it does hereby urgently request that the
22 Congress appropriate \$2,817,069. in accordance with the
23 attached proposals, to assist the Nation in meeting the
24 rise and demand for health services.

25 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
26 that the appropriate officers of the Nation are hereby
27 authorized and directed to bring this request to the
28 appropriate members and committees of Congress.

The foregoing Resolution was passed by the Tohono O'odham Council on the 6th day of March, 1991 at a meeting at which a quorum was present with a vote of 1,724.0 for; -0- against; -0- not voting; -0- absent, pursuant to the powers vested in the Council by Section 1(j) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
