NO. 91-080 1 WHEREAS, the Tohono O'Odham Nation has an unmet need for adequate 2 housing for its tribal members; and 3 WHEREAS, the Tohono O'Odham Nation supports the National Affordable 4 Housing Act as it relates to housing; and 5 WHEREAS, the National Affordable Housing Act designated the 6 following: 7 FYE 1991 - 233 million dollars for development (3000 8 units) FYE 1992 - 233 million dollars for development (3000 9 units); and 10 WHEREAS, the Tohono O'Odham Nation opposes the current government 11 administration's proposal of <u>-0-</u> funding for new 12 development. 13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Nation 14 supports the funding in FYE 1992 of 233 million dollars 15. for development of 3000 new units. 16 BE IT FURTHER RESOLVED that the Tohono O'Odham Nation opposes any 17 deletion or adjustment to the FYE 1992 funding for any 18 other purpose other than what is called out for under the 19 National Affordable Housing Act Legislation. 20 The foregoing Resolution was passed by the Tohono O'odham Council on the 6th. day of March, 1991 at a meeting at which a quorum was 21 present with a vote of 1,724.0 for; -0- against; -0- not voting; 03 absent, pursuant to the powers vested in the Council by Section 22 1(j) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, **2**3 and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
