

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriations Request for the Water Resources Inventory Study)

2 WHEREAS, Legislative Council did hear a request by the Water
3 Resources Department Acting Director the need to seek
4 additional funding for the Water Resources Inventory
5 Study; and

6 WHEREAS, the Legislative Council is aware that current funding is
7 not adequate to complete a comprehensive study of the
8 Nation's water resources in accordance with the Nation's
9 638 Contract for the Study; and

10 WHEREAS, the Legislative Council is aware that appropriations
11 requests approved by the U.S. Congress generally take two
12 years to reach Programs through the Bureau of Indian
13 Affairs; and

14 WHEREAS, it is the intent of the Tohono O'Odham Nation to fulfill
15 the conditions of the 638 contract for the Water Resources
16 Inventory Study; and

17 WHEREAS, the Legislative Council agrees the information gathered
18 by the Water Inventory Study is of inestimable importance
19 to current and future generations of Tohono O'Odham in the
20 management of their natural resources.

21 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it
22 hereby approves the Water Resources Department appropri-
23 ations request and directs the Nation's Appropriations
24 Committee traveling to Washington, D.C. to request
25 \$1,642,379 with which the Water Resources Inventory Study
26 can be completed.

27 The foregoing Resolution was passed by the Tohono O'odham Council
28 on the 6th day of March, 1991 at a meeting at which a quorum was
present with a vote of 1,660.5 for; -0- against; 63.5 not voting;
