2 WHEREAS, the Tohono O'odham Legislative Council, by Legislative  
3 Order No. 136-90, created the standing appropriations  
4 committee to follow up on the Federal Congressional  
5 Appropriations process and the Nation's priorities; and

6 WHEREAS, the Appropriations Committee's membership consists of the

11 WHEREAS, the Legislative Council Appropriations Committee has  
12 solicited and received various proposed funding requests  
13 from Programs and Departments for the FY'92 Federal  
14 Appropriations; and

15 WHEREAS, funding requests received will be submitted to the  
16 appropriate congressional committees, representatives, and  
17 federal agencies during the Appropriation Hearings  
18 scheduled to be held March 12-14, 1991 in Washington, D.C.

19 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
20 Council does hereby authorize the Appropriations Committee  
21 to testify and lobby on behalf of the Tohono O'odham  
22 Nation for funding requests for the Nation's priorities  
23 during the March 12-14, 1991 Appropriation Hearings in  
24 Washington, D.C.


25 BE IT FURTHER RESOLVED that the committee shall submit a report to  
26 the Tohono O'odham Legislative Council upon their return.

27 The foregoing Resolution was passed by the Tohono O'odham Council  
28 on the 6th day of March, 1991 at a meeting at which a quorum was  
present with a vote of 1,724.0 for; -0- against; -0- not voting;


