

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 399-90, Wire Transferring  
to Vi-ikam Doag, Inc)

RES. NO. 91-086

1 WHEREAS, Vi-ikam Doag Industries was chartered as a non-profit  
2 organization to develop business and employment  
3 opportunities for the San Lucy District; and

4 WHEREAS, the Board of Directors of Vi-ikam Doag Industries has  
5 submitted an operating budget for FY '91 in the sum of  
6 \$470,905.00 to support its activities on behalf of the San  
7 Lucy District; and

8 WHEREAS, the San Lucy District Council did review and approve of  
9 the activities and expenditure proposal in the budget; and

10 WHEREAS, the Legislative Council did approve the Vi-ikam Doag  
11 Industries FY '91 Budget by Resolution No. 399-90  
12 including an expenditure chart attached to the FY '91  
13 budget; and

14 WHEREAS, there was no statement in Resolution No. 10-66-90 of the  
15 San Lucy District and Resolution No. 399-90 of the Tohono  
16 O'Odham Legislative Council on how the funds shall be  
17 transferred to Vi-ikam Doag Industries, Inc. Account.

18 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
19 Council that the funds allocated to the Vi-ikam Doag  
20 Industries, Inc. shall have the following draw down  
21 schedule:

3 No. 2186-4764 at the Gila Bend Branch of the Valley

5 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council  
6 that the Tohono O'Odham Nation's officials, to wit: the  
7 Chairman, Vice Chairman and any designated official are  
8 hereby authorized to implement the wire transferring of  
9 funds to Account No. 2186-4764 at the Gila Bend Branch of  
10 the Valley National Bank, any amendments affecting the  
11 funding level of the preceding draw down schedule shall  
12 be submitted for further prior approval by this Council.

14 The foregoing Resolution was passed by the Tohono O'odham Council  
15 on the 6th. day of March, 1991 at a meeting at which a quorum was  
16 present with a vote of 1,724.0 for; -0- against; -0- not voting;  
17 03 absent, pursuant to the powers vested in the Council by Section  
18 1(d)(3) of Article VI of the Constitution of the Tohono O'odham  
19 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,  
20 and approved by the Acting Deputy Assistant Secretary - Indian  
21 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
22 the Act of June 18, 1934 (48 Stat. 984).
