NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
Council that it does hereby support and request that the
Tohono O'Odham Library Services be considered for funding
by the Library Services and Construction Act via the
State of Arizona, in accordance with the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's officials to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to apply for funding from the Library Services and Construction Act provided however, that any amendments affecting funding or funding levels of the grant shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 7th. day of March, 1991 at a meeting at which a quorum was present with a vote of 1,603.5 for; -0- against; 120.5 not voting; -0- absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono
