WHEREAS, the Tohono O'Odham Nation established a policy to require the inclusion of indirect costs in all third party funded agreements; and

RES. NO. 91-089

WHEREAS, the policy provides for an exception of the requirement by the Legislative Council if it is in the best interest of the Nation to do so, that is when the benefits to the Nation exceeds the need to collect revenues from the funding agency; and

WHEREAS, funding from the Department of Library, Archives and Public Records specifies an indirect cost not to exceed 6% and the Nation's proposed indirect rate is @ 16%; and WHEREAS, the services that will be derived from this funding will benefit members of the Tohono O'Odham Nation of all ages.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council finds that it is in the best interest of the Nation to waive the 10% indirect cost funding requirement for the FY '92 Library Services and Construction Act Funds.

The foregoing Resolution was passed by the Tohono O'odham Council on the 7th. day of March, 1991 at a meeting at which a quorum was present with a vote of 1,468.5 for; 113.0 against; 142.5 not voting; -0- absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
