WHEREAS, the two districts are Chukut Kuk and Gu Vo, are adjacent along 75 miles of International United States/Mexican Boundary; and

WHEREAS, there have been continuous problems of cattle rustling, drug trafficking and illegal entry of foreign nationals into the United States; and

WHEREAS, the Tohono O'Odham Nation's Police Force is extremely limited in man power and funds to cover the vast area within its boundaries including the International United States/Mexican Boundary.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative

Council does hereby request that Congress appropriate

\$733,914.00 in accordance with the attached proposal.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the appropriate officers of the Nation are hereby authorized and directed to bring this request to the appropriate members and committees of Congress.

The foregoing Resolution was passed by the Tohono O'odham Council on the <u>8th</u>. day of <u>March</u>, <u>1991</u> at a meeting at which a quorum was present with a vote of <u>1,724.0</u> for; <u>-0-</u> against; <u>-0-</u> not voting; <u>04</u> absent, pursuant to the powers vested in the Council by Section <u>1(i)</u> of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
