NO. 91-100 1 WHEREAS, the Personnel and Procedure Manual of the Tohono O'Odham 2 Nation provides for the establishment of a position 3 classification plan for employees of the Tohono O'Odham 4 Nation and for the development of procedures to implement 5 and maintain such plan; and 6 WHEREAS, the Personnel Office has submitted to the Tohono O'Odham Nation's Legislative Council a Position Classification 8 Plan with categories listed by salary range; and 9 WHEREAS, the Tohono O'Odham Nation's Legislative Council has 10 reviewed the materials submitted by. and the 11 recommendations of the Personnel Office and believes it 12 is in the best interest of the Tohono O'Odham Nation that 13 they be implemented at the start of FY 1992. 14 THEREFORE, BE IT RESOLVED by the Tohono O'Odham Nation's NOW, 15 Legislative Council that the Position Classification Plan 16 submitted to this Council by the Personnel Office is 17 hereby approved and adopted. Employees will be placed in 18 their appropriate category and paid according to the Range 19 and Step assigned in that process, provided that salaries **20** are not reduced for current employees. The effective date 21 of these assignments will be October 01, 1991. 22 BE IT FURTHER RESOLVED that before formal implementation, of any **2**3 and all pay changes necessary to operationalize the 24 Position Classification Plan, a full disclosure of the 25 fiscal impact of the Plan will be presented by Executive

to the Tohono O'Odham Nation's Legislative Council.
