WHEREAS, the Legislative Council of the Tohono O'Odham Nation is authorized to manage, budget and appropriate the funds of the Nation; and

WHEREAS, the Executive Branch of the Nation by and through recommendation of the Chairman's Designee and the Personnel Director to the Legislative Council have advised that the Nation's employees would benefit from a 3% cost of living adjustment to keep pace with inflation and employment practices in the general area of the Nation; and

WHEREAS, the Chief Financial Officer has advised the Legislative Council through revenue projections for Fiscal Year 1992 that adequate funds will be available to support a 3% cost of living adjustment for the Nation's employees.

NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'Odham Nation hereby approves a 3% cost of living adjustment for the Nation's employees effective October 1, 1991 for the Nation's fiscal year 1992.

BE IT FURTHER RESOLVED that the Executive Branch of the Nation is to direct that all budgets prepared and submitted to this Legislative Council for FY 1992 appropriations should include this 3% cost of living adjustment and from the effective date of this resolution all proposals submitted by the Nation for funds from federal, state, local and/or private entities should likewise include a request for funding consistent with this cost of living adjustment.
