

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a 3% Cost of Living Adjustment for all
Employees of the Nation, Effective October 1, 1991
for Fiscal Year 1992)

3 WHEREAS, the Legislative Council of the Tohono O'Odham Nation is
4 authorized to manage, budget and appropriate the funds of
5 the Nation; and

6 WHEREAS, the Executive Branch of the Nation by and through
7 recommendation of the Chairman's Designee and the
8 Personnel Director to the Legislative Council have advised
9 that the Nation's employees would benefit from a 3% cost
10 of living adjustment to keep pace with inflation and
11 employment practices in the general area of the Nation;
12 and

13 WHEREAS, the Chief Financial Officer has advised the Legislative
14 Council through revenue projections for Fiscal Year 1992
15 that adequate funds will be available to support a 3% cost
16 of living adjustment for the Nation's employees.

17 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the
18 Tohono O'Odham Nation hereby approves a 3% cost of living
19 adjustment for the Nation's employees effective October
20 1, 1991 for the Nation's fiscal year 1992.

21 BE IT FURTHER RESOLVED that the Executive Branch of the Nation is
22 to direct that all budgets prepared and submitted to this
23 Legislative Council for FY 1992 appropriations should
24 include this 3% cost of living adjustment and from the
25 effective date of this resolution all proposals submitted
26 by the Nation for funds from federal, state, local and/or
27 private entities should likewise include a request for
28 funding consistent with this cost of living adjustment.
