22 officers of the Tohono O'Odham Nation reduce this final
23 determination in writing regarding each of the foregoing
24 applications for enrollment in accordance with Section 3
25 (c) of Article III of the Enrollment Ordinance; give
26 notice of this Council's determination in accordance with
27 Section 4 of Article III of the Enrollment Ordinance; and
28 place the names of each applicant upon the membership roll
of the Tohono O'Odham Nation in accordance with Article
V of the Enrollment Ordinance.

The foregoing Resolution was passed by the Tohono O'Odham Council
on the 1st. day of April, 1991 at a meeting at which a quorum was
present with a vote of 1,546.5 for; -0- against; 63.5 not voting;
and 114.0 [4] absent, pursuant to the powers vested in the Council
by Section 1 of Article II and of Section 1 (h) of Article VI of
the Constitution of the Tohono O'Odham Nation, adopted by the
