WHEREAS, the Tohono O'Odham Legislative Council did by Resolution No. 91-104 adopt procedures for disclosure of confidential information regarding SAWRSA and U.S. y. Tucson; and WHEREAS, upon presentation of Resolution No. 91-104 to the Chairman

of the Tohono O'Odham Nation, he did disapprove thereof and returned it to the Council with his objections in accordance with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'Odham Nation; and

WHEREAS, the Tohono O'Odham Legislative Council has reviewed the Chairman's objections and after consideration, again voted to pass Resolution No. 91-104.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby override the Chairman's veto of Resolution No. 91-104, by a vote of two-thirds (2/3) of the votes cast.

The foregoing Resolution was presented to the Tohono O'Odham Council on the 4th. day of April , 1991 at a meeting at which a quorum was present and by a vote of 1,155.5 for; 399.0 against; 62.5 not voting; and 107.0 [7] absent was passed by a majority of at least two-thirds (2/3) [1.037.0] of the votes cast and became law as provided in Section 5 of Article VII of the Constitution of the Tohono O'Odham Nation.
