

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the Attorney General to Represent the
Tohono O'Odham Farming Authority on a Limited Basis)

2 WHEREAS, pursuant to Resolution 91-112, the Tohono O'Odham
3 Legislative Council authorized the Attorney General to
4 file a law suit (the "Law Suit") to prevent interruption
5 of water deliveries to the San Lucy Farm; and

6 WHEREAS, by Resolution 326-89, the Legislative Council enacted the
7 Statute Creating the Office of the Attorney General (the
8 "Statute"); and

9 WHEREAS, under Section 3(A) of the Statute, the Attorney General
10 is authorized to represent the Tohono O'odham Nation and
11 "such other entities as the Legislative Council shall
12 authorize the Attorney General to advise and represent";
13 and

14 WHEREAS, the Tohono O'Odham Farming Authority (the "Farm
15 Authority") was created pursuant to a Plan of Operation
16 adopted by Council Resolution 72-79, as amended by Council
17 Resolution 283-90; and

18 WHEREAS, the Farm Authority has entered into a General Counsel
19 Contract with the law firm of Strickland & Altaffer; and

20 WHEREAS, the legal interests of the Nation are primarily at issue
21 in the Law Suit; and

22 WHEREAS, it is nonetheless advisable to join the Farm Authority as
23 a party plaintiff for legal reasons; and

24 WHEREAS, it is advisable from both legal and financial perspectives
25 that the Nation and the Farm Authority be represented in
26 the Law Suit as parties plaintiff by the Attorney General;

2 WHEREAS, the law firm of Strickland & Altaffer has no objection to
3 representation of the Farm Authority by the Attorney
4 General in the Law Suit; and

5 WHEREAS, the Board of the Farm Authority has approved such
6 representation by the Attorney General.

7 NOW, THEREFORE, BE IT RESOLVED THAT:

8 the Tohono O'Odham Legislative Council hereby authorizes
9 the Attorney General to represent the Tohono O'Odham
10 Farming Authority solely for the purposes of the Law Suit.


11 The foregoing Resolution was passed by the Tohono O'odham Council

13 present with a vote of 1,174.0 for; -0- against; -0- not voting;
14 550.0 absent, pursuant to the powers vested in the Council by
15 Section 2(a) of Article VI of the Constitution of the Tohono
16 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
17 1986, and approved by the Acting Deputy Assistant Secretary -
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
19 16 of the Act of June 18, 1934 (48 Stat. 984).






