

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Community Health Services
Scope of Work and Budget Modification No.1)

2 WHEREAS, the Tohono O'Odham Nation is presently operating the
3 Community Health Services Program under FY 1991 P.L. 93-
4 638 contract with the Public Health, Indian Health
5 Services; and

6 WHEREAS, such tribal operation has been successful and beneficial
7 to the Tohono O'Odham Nation and its people; and

8 WHEREAS, the Tohono O'Odham Nation has been informed that tribal
9 contract support dollars and FY 1991 final allocations
10 have been received to provide services; and

11 WHEREAS, the Community Health Services has submitted for review a
12 revised scope of work and budget modification in order to
13 provide services to the O'Odham community.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
15 Council that it does hereby approve and request Indian
16 Health Services to modify the Community Health Services
17 Contract No. 249-88-0011 to incorporate the attached scope
18 of work and budget.

19 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
20 that the Tohono O'Odham Nation's officials, to wit: the
21 Chairman, Vice Chairman and any designated official are
22 hereby authorized to negotiate and execute the contract,
23 provided however, that any amendments affecting the
24 funding or funding levels of the contract shall be
25 submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 17th day of April, 1991 at a meeting at which a quorum was present with a vote of 1,610.0 for; 114.0 against; -0- not voting; 03 absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




