

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Behavioral Health Services - Alcoholism and
Community Based Training P.L. 99-570 Component)

2 WHEREAS, the Tohono O'Odham Nation is presently operating the
3 Behavioral Health Services Program (Alcoholism and
4 Community Based Training P.L. 99-570) component under FY
5 1991 P. L. 93-638 contract with the Public Health, Indian
6 Health Services; and

7 WHEREAS, such tribal operation has been successful and beneficial
8 to the Tohono O'Odham Nation and its people; and

9 WHEREAS, the Tohono O'Odham Nation has been informed that:
10 Alcoholism received an additional allocation for tribal
11 support dollars, Fiscal Year 1990 carry-over and FY 1991
12 final allocation and Community Based Training P.L. 99-570
13 component received additional allocation of \$26,000.00 to
14 provide community education and trainings for O'Odham
15 people; and

16 WHEREAS, the Behavioral Health Services Program (Alcoholism, and
17 Community Based Training P. L. 99-570) component has
18 submitted for review a revised budget modification in
19 order to provide services to the O'Odham Community.

20 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
21 Council that it does hereby approve and request Indian
22 Health Services to modify the Behavioral Health Services
23 Contract No. 249-89-0009 (Alcoholism and Community Based
24 Training P. L. 99-570) component to incorporate the
25 attached budget.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
that the Tohono O'Odham Nation's officials, to wit: the
Chairman, Vice Chairman and any designated official are
hereby authorized to negotiate and execute the agreement,
provided however, that any amendments affecting the
funding or funding levels of the agreement shall be
submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council
on the 17th. day of April, 1991 at a meeting at which a quorum was
present with a vote of 1,388.5 for; 57.0 against; 278.5 not
voting; 03 absent, pursuant to the powers vested in the Council
by Section 1(f) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).




