WHEREAS, the Tohono O'Odham Nation is presently operating the Behavioral Health Services Program (Alcoholism and Community Based Training P.L. 99-570) component under FY 1991 P.L. 93-638 contract with the Public Health, Indian Health Services; and

WHEREAS, such tribal operation has been successful and beneficial to the Tohono O'Odham Nation and its people; and

WHEREAS, the Tohono O'Odham Nation has been informed that:
Alcoholism received an additional allocation for tribal
support dollars, Fiscal Year 1990 carry-over and FY 1991
final allocation and Community Based Training P.L. 99-570
component received additional allocation of \$26,000.00 to
provide community education and trainings for O'Odham
people; and

WHEREAS, the Behavioral Health Services Program (Alcoholism, and Community Based Training P. L. 99-570) component has submitted for review a revised budget modification in order to provide services to the O'Odham Community.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
Council that it does hereby approve and request Indian
Health Services to modify the Behavioral Health Services
Contract No. 249-89-0009 (Alcoholism and Community Based
Training P. L. 99-570) component to incorporate the
attached budget.
