3 WHEREAS, the Tohono O'Odham Nation is presently operating the
4 Tohono O'Odham Psychological Services Children's
5 Initiative Program under FY 1991 P. L. 93-638 contract
6 with the Public Health, Indian Services; and

7 WHEREAS, such tribal operation has been successful and beneficial
8 to the Tohono O'Odham Nation and its people; and

9 WHEREAS, the Tohono O'Odham Psychological Services Children's
10 Initiative Program has submitted for review a revised
11 scope of work and budget modification in order to provide
12 services to the O'Odham Community.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
14 Council that it does hereby approve and request Indian
15 Health Services to modify the Tohono O'Odham Psychological
16 Services Children's Initiative Program Contract No.
17 249-90-0002 to incorporate the attached scope of work and
18 budget.

19 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
20 that the Tohono O'Odham Nation's officials, to wit: the
21 Chairman, Vice Chairman and any designated official are
22 hereby authorized to negotiate and execute the contract,
23 provided however, that any amendments affecting the
24 funding or funding levels of the contract shall be
25 submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 17th day of April, 1991 at a meeting at which a quorum was present with a vote of 1,325.0 for; 57.0 against; 342.0 not voting; and 03 absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


