NO. <u>91-129</u> 1 WHEREAS, the Tohono O'odham Nation has been administering the 2 Demonstration Project for the last two years; and 3 WHEREAS, the Demonstration Project was funded for a three year 4 period to end and the conclusion of fiscal year 1991; and 5 WHEREAS, the Demonstration Project was authorized and appropriated 6 by special action of the U.S. Congress; and 7 WHEREAS, the authorization for the Demonstration Project includes 8 a provision for an evaluation of the project; and 9 WHEREAS, there has been an appropriation of sixty-two thousand 10 dollars (\$62,000.) for the purpose of conducting such an 11 evaluation; and 12 WHEREAS, the Nation is desirous in meeting the goals and objectives 13 of the Demonstration Project; and 14 WHEREAS, a goal of the project is to develop human resources 15 policies and procedures that will enable the Nation to 16 contract programs and federal employees; and 17 WHEREAS, the Nation has available to it the Personnel Office who 18 has the overall responsibility of personnel management for 19 the Nation; and 20 WHEREAS, the Demonstration Project funding was to be utilized in 21 furthering the infrastructure of the Nation. **22** NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative 23 Council does hereby approve the attached 24 budget modification to increase the funding base of the **2**5 Demonstration Project to \$62,000. for the conduct of the 26 evaluation. 27
