WHEREAS, the Tohono O'odham Nation has been administering the Demonstration Project for the last two years; and

WHEREAS, the Demonstration Project was funded for a three year period to end and the conclusion of fiscal year 1991; and

WHEREAS, the Demonstration Project was authorized and appropriated by special action of the U.S. Congress; and

WHEREAS, the authorization for the Demonstration Project includes a provision for an evaluation of the project; and

WHEREAS, there has been an appropriation of sixty-two thousand dollars (\$62,000.) for the purpose of conducting such an evaluation; and

WHEREAS, the Nation is desirous in meeting the goals and objectives of the Demonstration Project; and

WHEREAS, a goal of the project is to develop human resources policies and procedures that will enable the Nation to contract programs and federal employees; and

WHEREAS, the Nation has available to it the Personnel Office who has the overall responsibility of personnel management for the Nation; and

WHEREAS, the Demonstration Project funding was to be utilized in furthering the infrastructure of the Nation.


NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the attached budget modification to increase the funding base of the Demonstration Project to \$62,000. for the conduct of the evaluation.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of the grant shall be submitted for further prior approval by this Council.


The foregoing Resolution was passed by the Tohono O'odham Council on the 17th day of April, 1991 at a meeting at which a quorum was present with a vote of 716.5 for; 503.5 against; 504.0 not voting; and 03 absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




