NO. 91-134 2 WHEREAS, the Tohono O'odham Nation is presently operating the 3 Tohono O'odham Title VII Bilingual Education Program under 4 a four (4) year grant with the U.S. Department of 5 Education, Office of Bilingual Education and minority 6 Languages Office; and 7 WHEREAS, negotiations were held and the Nation was informed of a 8 reduction in funding for the fourth year budget; and 9 WHEREAS, the Tohono O'odham Title VII Bilingual Education Program 10 has submitted a budget modification to reflect the reduction in funding for review and approval by the Tohono 11 O'odham Legislative Council. 12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative 13 Council that it does hereby approve the amendment to the 14 Title VII Bilingual Education Program grant and authorizes 15 expenditures in accordance with the attached budget. 16 17 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council 18 that the Tohono O'odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are 19 hereby authorized to negotiate and execute the grant. 20 21 provided however, that any amendments affecting the 22 funding or funding levels of this grant shall be submitted **2**3 for further prior approval by this Council. The foregoing Resolution was passed by the Tohono O'odham Council on the 18th day of April, 1991 at a meeting at which a quorum was present with a vote of 1,597.0 for; 127.0 against; -0- not voting; <u>06</u> absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of

the Act of June 18, 1934 (48 Stat. 984).
