

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Extension of the San Xavier Cooperative Farm Rehabilitation
Pre-Design/Design Contract No. 8-CS-30-04830)

2 WHEREAS, the Tohono O'odham Nation has been under contract to
3 provide predesign and design services under a P.L. 93-638
4 contract with the Bureau of Reclamation; and

5 WHEREAS, the three year P.L. 93-638 contract expired on 12 February
6 1991; and

7 WHEREAS, additional time is required to complete tasks which are
8 associated with the contract.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
10 Council that it does authorize the Chairman of the Tohono
11 O'odham Nation to request the Bureau of Reclamation to
12 extend Contract No. 8-CS-30-04830 (Predesign and Design
13 for the San Xavier Cooperative Farm Rehabilitation
14 Project) with the Tohono O'odham Nation under the P.L. 93-
15 638 Regulations.

16 BE IT FURTHER RESOLVED that the duration of this contract extension
17 commence on February 13, 1991 and end on September 30,
18 1991.

19 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
20 that the Tohono O'odham Nation's Officials, to wit: The
21 Chairman, Vice Chairman and any designated official are
22 hereby authorized to negotiate and execute the extension
23 of the contract, provided however, that any amendments
24 affecting the funding or funding levels of this contract
25 shall be submitted for further prior approval by this
26 Council.

27 The foregoing Resolution was passed by the Tohono O'odham Council
28 on the 18th day of April, 1991 at a meeting at which a quorum was
present with a vote of 1,724.0 for; -0- against; -0- not voting;
