(Extension of the Schuk Toak Predesign/San Xavier Contract  
No. 8-CS-32-00380)

2 WHEREAS, the Tohono O'odham Nation has been under contract to  
3 provide predesign services under a P.L. 93-638 contract  
4 with the Bureau of Reclamation; and

5 WHEREAS, the three year P.L. 93-638 contract is due to expire on  
6 22 April 1991; and

7 WHEREAS, additional time is required to complete tasks which are  
8 associated with the contract; and

9 WHEREAS, additional funds are required in order to pay for  
10 outstanding invoices from contractors to the Tohono  
11 O'odham Nation; and

12 WHEREAS, an amendment for consultant services for Predesign on the  
13 San Xavier New Farm (Modification #9 - Photogrammetry)  
14 has been submitted by the Tohono O'odham Nation's Water  
15 Projects Office for review and approval.


16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
17 Council that it does authorize the Chairman of the Tohono  
18 O'odham Nation to request the Bureau of Reclamation to  
19 modify and extend Contract No. 8-CS-32-00380 (Schuk Toak  
20 Predesign/San Xavier), consistent with budget modification  
21 #9, described above and attached hereto, with the Tohono  
22 O'odham Nation under the P.L. 93-638 regulations and  
23 authorizes expenditures in accordance with the attached  
24 budgets upon approval by the Bureau of Reclamation.

25 BE IT FURTHER RESOLVED that the duration of this contract extension  
26 commence on April 22, 1991 and end on September 30, 1991.


