

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Behavioral Health Services - Rehabilitation &  
Aftercare Program for Adolescents Budget Modification No. 1)

2 WHEREAS, the Tohono O'odham Nation is presently operating the  
3 Behavioral Health Services Program (Rehabilitation &  
4 Aftercare Program for Adolescents) under FY 1991 P.L. 93-  
5 638 contract with the Public Health, Indian Health  
6 Services; and

7 WHEREAS, such tribal operation has been successful and beneficial  
8 to the Tohono O'odham Nation and its people; and

9 WHEREAS, the Tohono O'odham Nation has been informed that:  
10 Rehabilitation and Aftercare Program for Adolescents  
11 component received an additional allocation for tribal  
12 support dollars, Fiscal Year 1990 carryover and FY 1991  
13 final allocation; and

14 WHEREAS, the Behavioral Health Services Program (Rehabilitation &  
15 Aftercare Program for Adolescents) component has submitted  
16 for review a revised budget modification in order to  
17 provide services to the O'odham Community.

18 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
19 Council that it does hereby approve and request the Indian  
20 Health Services to modify the Behavioral Health Services  
21 Contract No. 249-89-0009 (Rehabilitation & Aftercare)  
22 component to incorporate the attached budget modification.

23 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
24 that the Tohono O'odham Nation's Officials, to wit: The  
25 Chairman, Vice Chairman and any designated official are  
26 hereby authorized to negotiate and execute the contract,  
27 provided however, that any amendments affecting the

funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 22nd day of April, 1991 at a meeting at which a quorum was present with a vote of 1,610.0 for; 57.0 against; 57.0 not voting; 05 absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
