## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving Tohono O'odham Psychological Services Modification No. 1)

1 RES. NO. 91-153 2 WHEREAS, the Tohono O'Odham Nation is presently operating the 3 Tohono O'Odham Psychological Services Program under FY 4 1991 P. L. 93-638 contract with the Public Health, Indian 5 Health Services; and 6 WHEREAS, such tribal operations have been successful and beneficial 7 to the Tohono O'Odham Nation and its people; and 8 WHEREAS, the Tohono O'Odham Nation has been informed that tribal 9 contract support dollars and FY 1991 final allocations 10 have been received to provide services; and 11 WHEREAS, Resolution No. 154-90 increased the Tohono O'Odham 12 Nation's fringe benefit coverage to include: 13 Comprehensive Medical, Dental, Death Dismemberment, Long 14 Term Disability and Retirement Insurance Policies for its 15 employees; and 16 WHEREAS, it is in the Nation's best interest that funds available 17 for contract support cost be distributed to cover the 18 additional increase of employee benefits; and 19 WHEREAS, the Tohono O'Odham Psychological Services has submitted 20 a budget modification to cover additional employee 21 benefits and program costs for review and approval. **22** NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative 23 Council that it does hereby approve and request Indian 24 Health Services to modify the Psychological Services 25 Contract No. 249-90-0002 to incorporate the attached 26 budget modification. 27
