NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that the scheduled May General Session is hereby postponed and rescheduled to the week of May 13-17, 1991 in order that the Legislative Council may convey its utmost respect and condolences to the late Representative Cross Antone and his family.

The foregoing ORDER was passed by the Tohono O'odham Council on the 6th day of May, 1991 at a meeting at which a quorum was present with a vote of 1.724.0 for; -0- against; -0- not voting; 05absent, pursuant to the powers vested in the Council by Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
