
6 BE IT FURTHER RESOLVED that the Chairman and other appropriate

5 on the 13th. day of May, 1991 at a meeting at which a quorum was
6 present with a vote of 1,484.5 for; 186.5 against; 53.0 not
7 voting; and 03 absent, pursuant to the powers vested in the
8 Council by Section 1 of Article II and of Section 1 (h) of Article
VI of the Constitution of the Tohono O'Odham Nation, adopted by the
Tohono O'Odham Nation on January 18, 1986 and approved by the
Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
March 6, 1986 pursuant to Section 16 of the Act of June 18, 1934
(48 Stat. 984).




