1 RES. NO. 91-168 2 WHEREAS, the Tohono O'Odham Garage provides automotive service to 3 vehicles which are owned or leased by the Nation, and 4 which are used by the Nation's programs and departments; 5 and 6 WHEREAS, the Garage's equipment for mounting, balancing, repairing 7 and servicing tires has unexpectedly broken down, due to 8 age and wear; and 9 WHEREAS, such equipment is needed to carry-on the normal duties of 10 the Garage and without this equipment, tire service has 11 been performed by retail repair facilities at greater 12 costs. 13 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the 14 Tohono O'Odham Nation that funds in the amount of \$3,500 15 are appropriated from general revenues for the purpose of 16 increasing the budget of the Tohono O'Odham Garage. 17 BE IT FURTHER RESOLVED that the budget of the Tohono O'odham Garage 18 is modified according to the attached description to 19 account for this increase. 20 The foregoing Resolution was passed by the Tohono O'odham Council on the 13th. day of May, 1991 at a meeting at which a quorum was 21 present with a vote of 1,724.0 for; -0- against; -0- not voting; 02 absent, pursuant to the powers vested in the Council by Section 22 1(d) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, 23 and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of 24 the Act of June 18, 1934 (48 Stat. 984). 25 TOHONO O'ODHAM LEGISLATIVE COUNCIL 26
