NO. 91-172 2 WHEREAS, the Tohono O'Odham Nation has operated a Head Start 3 Program to provide and serve educational and pre-school 4 learning experiences for children between ages 3-5 years; 5 and 6 WHEREAS, the Department of Health and Human Services, has advised 7 the Nation to submit a proposal to use its carry-over 8 dollars and to provide sufficient justification to support 9 this request; and 10 WHEREAS, the Head Start Program has prepared a proposal for the use 11 of the carry-over funds to be submitted to the Department 12 of Health and Human Services. 13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative 14 Council does hereby approve the Head Start Carry-Over 15 Proposal. 16 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council 17 that the Tohono O'Odham Nation's officials, to wit: the 18 Chairman, Vice Chairman and any designated official are 19 hereby authorized to negotiate and execute the grant 20 provided however, that any amendments affecting the 21 funding or funding levels of the grant shall be submitted 22 for further prior approval by this Council. 23 The foregoing Resolution was passed by the Tohono O'odham Council

The foregoing Resolution was passed by the Tohono O'odham Council on the 14th. day of May, 1991 at a meeting at which a quorum was present with a vote of 1,423.5 for; 114.0 against; 186.5 not voting; 02 absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
