3 WHEREAS, the Tohono O'Odham Nation by Resolution No. 154-90 has
4 mandated an increase in fringe benefit costs of an
5 additional 16% of salaries and wages for all programs; and

6 WHEREAS, the fringe benefit amount required by the Low Income Home
7 Energy Assistance Program, Parenting Skills Program and
8 Family Preservation Project to satisfy this mandate is
9 \$496.00; \$2,342.00; and \$12,454.00 respectively for a
10 grand total of \$15,292.00; and

11 WHEREAS, the programs identified have performed budget analysis and
12 determined budgeting for the additional 16% would have an
13 unacceptable negative impact in delivery of services by
14 the program; and

15 WHEREAS, the Low Income Home Energy Assistance Program, Parenting
16 Skills Program and Family Preservation Project hereby
17 request a grand total amount of \$15,292.00 to supplement
18 the program budget to meet the costs of increased fringe
19 benefits.

20 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
21 Council does hereby approve the supplemental request and
22 authorize expenditures in accordance with the attached
23 budget.

24 The foregoing Resolution was passed by the Tohono O'odham Council
25 on the 20th day of May, 1991 at a meeting at which a quorum was
26 present with a vote of 1,502.5 for; -0- against; 221.5 not
27 voting; 04 absent, pursuant to the powers vested in the Council
28 by Section 1(d) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
