mandated an increase in fringe benefit costs of an additional 16% of salaries and wages for all programs; and WHEREAS, the fringe benefit amount required by the Low Income Home Energy Assistance Program, Parenting Skills Program and Family Preservation Project to satisfy this mandate is \$496.00; \$2,342.00; and \$12,454.00 respectively for a grand total of \$15,292.00; and

WHEREAS, the programs identified have performed budget analysis and determined budgeting for the additional 16% would have an unacceptable negative impact in delivery of services by the program; and

WHEREAS, the Low Income Home Energy Assistance Program, Parenting Skills Program and Family Preservation Project hereby request a grand total amount of \$15,292.00 to supplement the program budget to meet the costs of increased fringe benefits.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby approve the supplemental request and authorize expenditures in accordance with the attached budget.

The foregoing Resolution was passed by the Tohono O'odham Council on the 20th. day of May, 1991 at a meeting at which a quorum was present with a vote of 1.502.5 for; -0- against; 221.5 not voting; 04 absent, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
