WHEREAS, it is necessary to provide adequate support staff to oversee the Personnel functions of the Papago Bingo and to interface with the Personnel Department of the Tohono O'Odham Nation; and

WHEREAS, this employee would be at a Manager (103.01) level, and all cost related to this position would be paid for by Papago Bingo; and

WHEREAS, the Papago Bingo Personnel Manager will be under the direct supervision of the Tohono O'Odham Personnel Director; and

WHEREAS, it may become necessary to create and or process the paperwork for all employees, including benefits; and

WHEREAS, it may become necessary to utilize Human Resource Consultants to assist the Papago Bingo Personnel Manager to expedite the accomplishment setting up personnel files, filling out forms, etc., and to be consistent with the Nation's policies in a timely manner; and

WHEREAS, even though these actions are reimbursable by Papago Bingo, it is felt to be in the best interest of the Nation that a budget be approved in the event that Legislative Council would order immediate action to accomplish this function.




