FRANCISCO, or 7 ALBERT MANUEL, JR. 8 WHEREAS, Councilman Virgil Lewis received 1,289.5 votes, Council-9 Earl A. Francisco received 318.0.0 votes, 10 Councilman Albert Manuel, Jr. received 116.5 votes; and 11 WHEREAS, receiving a majority of the votes cast, Virgil Lewis was 12 elected as Vice Chairman of the Tohono O'odham Legislative 13 Council. 14 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative 15 Council that it hereby certifies the election of and seats 16 Virgil Lewis as Vice Chairman of the Tohono O'odham 17 Legislative Council. 18 The foregoing ORDER was passed by the Tohono O'odham Council on the 3rd day of June, 1991 at a meeting at which a quorum was present with a vote of 1,724.0 for; -0- against; -0- not voting; absent, pursuant to the powers vested in the Council by Section 20 1(b) of Article VI of the Constitution of the Tohono O'odham 21 Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 23 TOHONO O'ODHAM LEGISLATIVE COUNCIL 24
