## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Base Roll Addition)

WHEREAS, Section 1 (a) of Article II of the Constitution of the Tohono O'Odham Nation provides that the Tohono O'Odham Council can make additions and changes to the official census rolls of the Sells and Gila Bend Reservations dated January 1, 1937 and of the San Xavier Reservation dated January 1, 1940, subject to the approval of the Secretary of the Interior; and

WHEREAS, the Enrollment Committee has determined that the following named person was a member of the Tohono O'Odham Nation on the date of the respective census rolls but that their name had been inadvertently omitted therefrom, and has recommended that their name be added to the rolls; and

WHEREAS, the Tohono O'Odham Council has reviewed the recommendations of the Enrollment Committee and approves thereof.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that, subject to the approval of the Secretary of the Interior, the name of the following person be added to the official census rolls of the Sells, Gila Bend or San Xavier Reservation, to wit:

## 98-ND-90 ZEPEDA-VALENCIA, Maria

BE IT FURTHER RESOLVED that the required approval be secured from the Secretary of the Interior before their name(s) is formally added to such rolls.
